Fire Standards Development - Progress Summary

The table on the following pages summarises the progress made against each Fire Standard included in phase one. The general progress report at *Item 5 – Paper 3* includes an update on recruitment as increasing resource and the impact of the response and recovery to the COVID pandemic have an influence on the ability of the CPO to progress at speed.

A reminder of what work is done in each of the three stages is contained in *Appendix B - Fire Standards* development process and governance stages. The first five Fire Standards listed will have completed the first stage of development by the end of June.
